#### **Brainstorm Activity**

- After time is called, place the chart paper on the wall and have the students conduct a gallery walk. Teacher should facilitate discussion among the students. Students should share ideas and respond to questions from each other on the topic.

- When time is called, each group will take turns sharing their different debate perspectives with the rest of the class.





#### Vocabulary Activity (modified)

#### Frayer Model (Graphic Organizer)

- Each student will be provided with a Frayer Model template.
- The vocabulary word will be placed in the middle of the template. The outer areas of the template will contain the following:
  - definition of the word
  - characteristics of the word (this can also be an illustration)
  - an example of the word
  - an example of what the word is not (a non-example).
- A separate model should be created for each new vocabulary word.

- Expertise & Intellectual Capital Bermuda has world-class intellectual capital (employees with lots of knowledge). This includes top accounting firms, financial advisers, lawyers, IT specialists, actuaries, (re)insurance underwriters, brokers, and many other professionals.
- Speed to Market There is a great advantage of being able to setup operations quickly and start delivery of services and products to clients/customers.
- Geography Bermuda has daily direct flights to major U.S. cities, as well as Toronto, Canada and London, England. Bermuda's favourable Atlantic Standard Time (AST) zone, makes it an ideal location for companies serving global markets.

- Expertise & Intellectual Capital Bermuda has some of the best employees in the world working in and supporting international business. They have a lot of knowledge and skills for their jobs. For example there are: top accounting firms, financial advisers, lawyers, IT specialists, actuaries, (re)insurance underwriters, brokers, and many other professionals.
- Speed to Market There is a great advantage of being able to setup companies quickly and start delivery of services and products to clients/customers.
- Geography Bermuda has daily direct flights to major U.S. cities, as well as Toronto, Canada and London, England. Bermuda's time zoneis excellent for companies who do business in other countries around the world.

### **Key Facts**

- Taxes Taxes in Bermuda are reasonably low compared to other parts of the world. This adds to the attractiveness of doing business in Bermuda.
- Entrepreneurial Culture Bermuda has fostered an entrepreneurial culture. Companies can try new ideas and ways of doing business easily in Bermuda. This helps them to stay competitive.

#### **Key Facts** (modified)

- Taxes Taxes in Bermuda are low compared to some other countries. This adds to the reasons companies want to be in Bermuda.
- Entrepreneurial Culture Bermuda is a place where companies can try new ideas and ways of doing business. This helps companies to compete with other companies.





## **Key Threats**

- Attracting and Retaining Intellectual Capital Attracting local and international talent (knowledgeable employees) is becoming more difficult as Bermuda competes on a global platform. It's important that Bermuda provide a stable work environment and compensation that is competitive. It is also important that opportunities for development are provided so that employees can grow professionally.
- Service Standards as we compete on the global stage it's important that we continue to improve our service standards.
- Inability to adapt to change In today's rapidly changing and highly competitive marketplace, it is crucial for organizations to be flexible enough to change, in order to remain profitable and ahead of the competition.

#### **Key Threats** (modified)

**Teacher instructions**: Read the slide below aloud or have students take turns reading it. Stop at regular intervals to break down the language. Then provide the students with a handout with some words removed have the students fill in the blanks.

- OHiring Qualified People— Attracting the best employees is becoming more difficult as Bermuda competes with the rest of the world for employees. It's important that Bermuda provide a good work environment and pay good salaries. It is also important that employees are given training to help them improve their skills.
- Customer Service— Bermuda workers must give excellent service so that people want to do business in Bermuda.
- Not Changing Companies must be prepared to change because the world is changing and the needs of people and markets are changing. If Bermuda companies keep up with change Bermuda will be a place where companies and workers want to be.

oPolitical, Social and Economic Stability - Although our economic and political framework is good, over the past several years we have experienced a slow economy performance which has affected us politically and socially in a negative manner.

Continuing to be a Safe Place where people live well that has Good Government -

Most people in Bermuda live well, but Bermuda has had a slow economy recently. The slow economy made it hard for many people to find work, so people did not have a lot of money to buy things that they needed. Some people think it also caused the increase in crime.

# **Key Threats**

- Weak Financial System the success or failure of the world's large countries like the United States, Europe, and China, has an effect on Bermuda.
- •International Regulation Bermuda's high regulatory standards and compliance with the various requirements to maintain a good reputation internationally.
- Global Tax Impact Policies have been developed to ensure that taxes are paid where the economic activities generating the profits are performed.

### **Key Threats** (modified)

- Fragile Global Financial System the success or failure of the world's large economies such as: the United States, Europe, and China, has an effect on Bermuda.
- •International Rules Bermuda's rules and high standards help us. Also, Bermuda obeys the requirements of other countries. This helps us to keep a good reputation internationally.
- **Effect of Global Tax** Rules have been developed so that taxes are paid in the country where the activities that give the company profits are done.

# **Key Threats**

• Black Lists - although the Bermuda Government and the BMA have made every effort to comply with the requirements to align our status as a non tax haven, we continue to be threatened with listing on various "blacklists" around the world.



### **Key Threats** (modified)

OBlack Lists - The Bermuda Government and the Bermuda Monetary Authority have made every effort to meet the requirements so that Bermuda will not be seen as a tax haven. Unfortunately, we continue to be threatened with listing on some "blacklists" around the world.





#### IS BERMUDA A TAX HAVEN?

The Organization for Economic Cooperation and Development (OECD) set out factors to identify tax havens. They looked at three areas.

- No or limited tax on income
- Lack of transparency
- Lack of information exchange



# IS BERMUDA A TAX HAVEN? No. Bermuda is not a tax haven.



- ✓ There are taxes in Bermuda
- ✓ Bermuda does not target companies for tax purposes
- ✓ Bermuda's tax revenue percentage is basically parallel to the U.S. tax percentage

# IS BERMUDA A PLACE COMPANIES and PEOPLE GO to AVOID PAYING TAXES (a tax haven)? No. it is not. (modified)



- ✓ There are taxes that must be paid in Bermuda
- ✓ Bermuda does not target companies for tax purposes
- ✓ The money Bermuda gets for taxes is basically the same as the taxes paid in the U.S.A.

Committed but not substantially implemented International standard


#### **Black List**



During USA/Bermuda signing of Fatca agreement in the Bermuda Senate Chamber in December 2013, the then US Consul-General to Bermuda, Robert Settje, responded to a journalist that the US Government did not consider Bermuda to be a tax haven.

 Develop a video commercial or news report highlighting Bermuda as a great place for international business.

This activity can be completed in groups with the teacher providing assistance to groups as the complete the activity.

Write a speech explaining why Bermuda is not a Tax Haven
 Students could verbalize the speech and receive assistance writing it.





# International Business is Important to Bermuda

- oInternational Business (IB) employs more than 3,800 people in Bermuda, 2,000 of them are Bermudian.
- An additional 6,000 employees are working for companies supporting IB like banks, law firms and accounting firms.
- International Business contributes to more than 55% of our foreign exchange.
- Almost half of the payroll tax the Bermuda government receives comes from international business. Taxes help the government to pay for road improvement, buses and ferries, public education, trash collection and much more.

International Business employees who live in Bermuda buy local goods and services 12 months a year. On average, one IB resident contributes the same dollar amount per year as 76 tourists arriving by airplane and 630 tourists who arrive by cruise ship.
